

#### **Apprenticeship ILR Returns Cycle**




- ✓ The ILR data is collected monthly in arears throughout the academic year: from 01<sup>st</sup> of August to 31<sup>st</sup> of July
- ✓ 12 x monthly returns / academic year: September (R01) -> August (R12)
- ✓ Submit your ILR by 4th working day of the month (with exception of R13 & R14).
- ✓ 2 x extra returns / academic year: September (R13) -> October (R14)



#### **Apprenticeship Data Validation**

1. Rule Violation Report




- ✓ UKPRN (Provider Reference Number)
- ✓ ULN (Unique Learner Number)

2. Data Match Report

- ✓ Apprenticeship course (i.e. Framework or Standard Code)
- ✓ Cost = Total Negotiated Price
- ✓ Start Date on the ILR is not earlier than Start Date on the App. Service (AS)
- ✓ Stop Date of the current or any previous apprenticeship for this learner








#### **Good Practice: Rule Violation**


